

# RED BULL RING COVID-19 CUSTOMER INFORMATION AND CATALOGUE OF MEASURES

## Introduction

Due to the COVID-19 pandemic, preventative measures are required for all customers of the Red Bull Ring.

The following COVID-19 catalogue of measures describes the basis for ensuring the best possible infection prevention for all people involved.

In addition to the preventative measures, avoiding further infections should a COVID-19 case still occur is a priority.

The aim of the measures is to create the medical requirements needed to allow a variety of activities to take place at the Red Bull Ring.





# **COVID-19 CATALOGUE OF MEASURES**

Everyone is obliged during the entire time of their stay at the Red Bull Ring complex to adhere to all operational and legal hygiene requirements and measures noted in this catalogue of measures.

# **Organisors and participants**

Everyone must be healthy and feel healthy and well.

Persons arriving from abroad must comply with the relevant arrival regulations at their time of entry to Austria.

In addition to all the measures specified, any kind of interaction with people not part of the organisation or event group must be avoided.

• Every organiser must complete and sign a <u>"COVID-19 declaration for organisers"</u> form (Attachment 1) then send this to the relevant contact person at the Red Bull Ring <u>in advance</u>.

In addition, each participant as well as the entire support staff and guests must complete and sign a "COVID-19 participant declaration" (Attachment 2.), and send this to the organiser in advance.

A copy of these participant declarations must be given to the responsible contact person at the Red Bull Ring on site by the organiser. These participant declarations will be destroyed after a period of 28 days.

Access to the paddock is only permitted for persons who have already submitted their COVID-19 participant declaration (Attachment 2) and received their wristbands.



# **Red Bull Ring staff**

The staff of the Red Bull Ring and staff of service providers also receive an appropriate briefing on rules and measures, which is continuously being updated due to the evolving legal requirements and recommendations.

# **Test concept**

Upon entering the defined work area, each participant must provide one of the following proofs:

- SARS-CoV-2 antigen test (not older than 48h)
- Molecular biological test on SARS CoV-2 (PCR test not older than 72h)
- Medical confirmation of infection with SARS-CoV-2 in the past 6 months, confirmed by molecular biology
- Evidence of vaccination with a centrally approved vaccine against COVID-19 under the following conditions:
  - Initial vaccination after the 22nd day, which must not be more than 3 months old
  - o or Second vaccination, which must not be more than 9 months old
  - Vaccination after the 22<sup>nd</sup> day, for vaccines for which only one vaccination is scheduled and not more than 9 months ago

# General hygiene concept

The key requirement for minimising the risk of transmission is compliance with all basic hygiene measures. For this reason, observing the following rules is essential:

## Regular handwashing

There are many sinks located around the area of the Red Bull Ring with plenty of soap. The soap and paper dispensers are checked and refilled at regular intervals in accordance with the cleaning and hygiene concept.

## Hand disinfection

Hand sanitiser dispensers are provided at all central points of the area, i.e. at all entrances, exits and key routes. These are also checked and refilled at regular intervals in accordance with the cleaning and hygiene concept.

# Coughing and sneezing hygiene

If coughing or sneezing

- o Place the inside of your elbow over your mouth and nose
- o Turn away from others

Wash hands thoroughly after blowing your nose, sneezing or coughing.

# Social distancing

A 1m social distance to other people is recommended all times.

# • <u>Using a clinical-mask</u>

Wearing a clinical-mask is not mandatory but highly recommended in all indoor areas!

Signs are clearly positioned throughout the Red Bull Ring grounds to indicate the basic hygiene measures.

# Hygiene equipment

The Red Bull Ring provides sufficient hygiene items (soap and paper towels) in sanitary areas.

For personal hygiene equipment (clinical-masks, personal hand sanitiser), all participants are personally responsible.

## Meals at the race circuit

Meals should be organised at the Red Bull Ring without crowds resulting.

Available rooms and services in the buildings of the Red Bull Ring can be offered and used in accordance with the legal requirements valid at the time of the event.

# **Dealing with suspected COVID-19 infections**

Possible symptoms include

Impact on the sense of taste or smell



- o Fever, cough, sore throat and body aches
- o Breathing problems

Should any of these symptoms occur, they need to be notified immediately to the appropriate person and the symptom carrier's participation or presence at the Red Bull Ring area is prohibited.

# When symptoms occur, the following steps must be held:

- Avoid contact with other people
- Remain in your accommodation or return to your accomodation
- Notify the contact person immediately
- Call the COVID-19 Hotline (1450)
- Follow the instructions of the hotline

This ensures that all legal measures and regulations are complied with when there is a suspected case of COVID-19.

To minimise the risk of transmission, further preventive measures are required for all sporting activities.

# **Paddock operations**

- Particular attention must be paid to the relaxed parking of vehicles in the paddock.
- The number of people who work in the entire area, especially in the work areas with limited space, must be reduced to a minimum.
- Accompanying persons and spectators are only permitted according to any limits specified by law at the time.

### Pits

- The gates to the pits should be kept open, if possible.
- Only participants and necessary support staff are allowed to remain in the pits.
- Access to the pits is not permitted for accompanying persons and visitors.



# Pit lanes and pit wall

- Only participants and necessary support staff are allowed to remain in the pit lane and on the pit wall.
- Monitoring of compliance with all regulations for the pit lane and the pit wall must be performed by specially trained supervisory staff.
- The need for supervisory staff to be deployed in these areas depends on the number of participants and must therefore be coordinated with the Red Bull Ring in advance.

## **Race Control**

- It is forbidden for people who are not required for operations to be in the Race Control Center.
- Communication with Race Control should be conducted digitally (telephone/radio).

# **Administrative approval**

- Administrative approval should be arranged in advance and preferably organised electronically.
- Should this not be possible, administrative approval must be designed in such a way that a gathering of people is avoided. The procedure for this must be coordinated with the Red Bull Ring in advance.

# **Driver briefing**

- Driver meetings should preferably be organised electronically.
- Should this not be possible, they must be organised in compliance with all specified measures and must be coordinated with the Red Bull Ring in advance.



# Winners ceremony

The holding of trophy ceremonies depends on the regulations for sports facilities valid at the time of the event and must be discussed in advance with the Red Bull Ring.

## **Medical facilities**

Medical primary care for racing drivers, participants and support staff is provided by the Medical Center in the pit building during race-track operating hours:

# Medical Center:

The team at the Medical Center consists of doctors, nursing staff and emergency paramedics.

A health check facility and an isolation unit are installed in front of the Medical Center. During the health check, symptom queries and temperature measurements are carried out. There is an adjoining isolation unit in which individuals suspected of having COVID-19 can be treated separately if required.
